So I made about 5 or 6 deepdives all on the topic of the same thing, that letter, the cover letter to my FORM 1.

Oh yeah, scroll to the bottom and checkout my new sig, I'm really proud of this title and this is what I am, What I always was. I am a Human Rights Activist working professionally at the Human Rights Tribunal of Ontario (HRTO). That's not gonna change.

But I did take issue with one thing, Admittedly you falling for my strategy is, it indicates it is also likely to fool the opposition counsel in a similar manner, you said my remedies are completely unworkable....

Michele Warner:

There's no change in Hell I'd ever sign that, admitting liability to something like that, are you crazy? Registrar the Applicant is trolling, I couldn't every sign that, it's COMPLETELY UNWORKABLE.

[I should have included a short clause, if HRTO does not wish to make them sign a letter, [they can but generally they really don't like doing that] the final remedy offered should be this: "HRTO imposes full liability on CAMH should these charges be proven true."]

[that would have been smarter, though the letter alone kind of forces their hand, they have to say no, they have to say]

Michele Warner:

That is a crazy thing to ask, No I won't sign it, You're asking me to admit liability for thousands of deaths, call it sickening... state.....

Brendan Rose:

You must state that these people are human. You have caused thousands of deaths maam, Thousands of people are dead because of you and your institution. They are, verifiably, and obviously.

I also requested you state "they are human" The people you killed are human, or used to be, they are rotten vegetables now. You killed them. So yes, I fully expect you to state that those people you murdered by the thousands are human.

Michele Warning:

No i.....

Brendan Rose:

You must state that these crimes are sickening.
You have killed thousands of people it is sickening.
Say it, admit it, you are killing people on an
industrial scale, sickening barely covers it.

But as I understand it, what you're trying to say Michele,
is that you will in no way ever express "remorse" for the
thousands of people dead as a result of your actions and
the actions of the Brutal CAMH organization.
Those people WERE human, Michele, they are not now,
they are buried in graves now, you put them there.

You will express remorse and regret for the thousands
of people you murdered. You will state that they were human.

Michele Warner:

Registrar, are you really going to allow this.....

Brendan Rose:

Michele, I know you think stating the thousands of people you killed,
I would estimate 200000 over 20 years, you think saying they were
human, is "absurd". You think you will never express "remorse"
or "regret", you believe you have killed them, that they are not human,
and that you will never feel remorse or regret.....

You have stated you will never say the names of pets you killed,
Loki, Tequila, Neko my favorite. They're dead now.
Your position is you will never say their name under any circumstances.
I'm here to tell you that you're wrong. You will.

By the end of these proceedings you will wring your hands
to God cry, for you have killed hundreds of thousand of people,
tortured to death over decades of unimaginable suffering, abuse,
mockery, humiliation, torture, especially the torture.
You will express remorse and regret that you have murdered so many people.....

Michele Warner:

...

Brendan Rose:

You will state publicly that your mass grave of victims,
contained human beings, before you exterminated them,
with slow torture over decades. Your heart will change,
You will turn to God, and cry and scream to God,
and beg him for forgiveness. Which he will grant you,
if you say they were human, first, that you feel remorse

and regret, for the humiliating extermination campaign
resulting in a mass grave with 200,000 who killed themselves
rather endure more suffering at the hand of CAMH,
and you Michele.

On that day you will not be concerned with legal liability,
because you will also be human that day for the first time
in many years. You will accept full legal liability for the
Genocide you caused.

The RCMP upon reading the letter,
Will realize with some disbelief,
You have just confessed to crimes against humanity.

They take you Michele, put you in a jail cell for a time,
Then under the laws of Canada, they will put a needle
in your arm and you will die. Which is our law in this country.

6.1 What Happened

Describe each event where you allegedly experienced discrimination under the Code.

1. * ODSP, an outgrowth of the CAMH System, Caps income at levels which mathematically make Homelessness a requirement for service. If victims of this abusive system in any way begin to rise out of poverty, the carpet is pulled out from under them, and they are cutoff from all help, thrusting them back down into poverty and homelessness by design. Measures are put in place to financially penalize and retaliate against family associations and relationships or marital partners who attempt to save the victim from dying a slow and painful death on the street over years of suffering. If they persist in helping the victim stay off the street, they are brutally retaliated against, and the carpet is pulled out from under them, their services are cutoff permanently, and they are thrust back into poverty. Starvation and homelessness is a form of torture (or the imposition of suffering) targeted against disabled and mentally ill people, specifically ---
2. * In other words, the torture and finally the imposition of death by exposure of the mentally ill is inflicted, imposed with brutal efficiency by the abusive CAMH edifice, which denies them even the slightest dignity, in this humiliating exercise, beginning at the early teenage years, and continuing throughout the victims entire life, until the victim commits suicide (1500 per year are tortured and tormented to death in this manner). These suicides are used mockingly in CAMH advertisements, using the deaths they caused, as reason to "help them further" (the infliction of further torture of homelessness, humiliating abuse, the denial of code [and charter: unrelated to HRT0] based rights, humiliating measures imposed with the goal [I will argue malice, though failing that, adverse effect as a fallback position, I argue malice is likely true, but if it is not malice, it is sheer lazy incompetence leading to the deaths of thousands imposed via suffering starvation humiliation imposed celibacy
3. * -etc. resulting in preventable deaths in large numbers. This was the result of the DOUG FORD government's policies. There was a time the system was far less brutal, and these deaths are the direct result of those policies. As I was a victim of this system, I have experienced most of this to one extent or another, CAMH and ODSP policies designed to destroy romantic relationships imposed egregious and onerous requirements on my wife, my pregnant wife, demanding she report her income to ODSP so it could be removed from my meagre, homeless man's wage they pay. These financial measure disgusted my wife, the point of the policy, she had a mental due to the financial abuse, creating an altercation that resulted in her being put in prison for several days, with a GAG ORDER imposed by Toronto Police Services Notorious 14 Division. This gag was maintained until the marriage was fully destroyed, and she was too afraid of the institutions abusing me, she ran away forever, never to return or speak
4. * To me ever again. This was a historical incident occuring in 2021, (this goes back before 2010, it has been decades of abuse beyond conception) My wife is gone, my baby is gone, as a result of their policies, my 3 pets are gone, I have no one and nothing now, (the general condition these policies are attempting to implement.) More recent incidents will be discussed moving forward as we progress. There is not enough space on these forms to express even 10% of these abuses. I am permanently traumatized by the horrors i have experienced and the family i have lost. I will never recover from the two (month long) imprisonments DR MARTIN ROTENBERG inflicted on me in 2024. After that I stopped smiling, I have not smiled or been happy since that year, if i smile it is forced. Instead I am shellshocked with a thousand yard stare that never goes away. As if I was a victim of a totalitarian regime that tortured me in a prison camp, this may not be so far off the mark. The CAMH prison complex is a

5. * form of torture I simply cannot endure anymore. All of these abuses are specifically inflicted and justified on the basis of my "mental illness". Charter right to decide treatment? "mental illness" denied. The right to be free from arbitrary and extrajudicial punitive imprisonment & torture, used by police as their GO TO SOLUTION for all problems involving people with this protected" characteristic. The imposition of arbitrary and punitive imprisonment for months (at times for life) (at times lobotomy- the cutting out of pieces of the brain, currently practised at CAMH on victims deemed "resistant to medication") The medication is imposed by force, failure to attend these humiliating injections, results in capture by police, and arbitrary torture of extra judicial imprisonment in a CAMH prison complex (they are not hospitals, except, perhaps if reminiscent of historical regimes of a similar persuasion, the "hospitals" are a place of torture. The torture of arbitrary unjust imprisonment.)

I was told he would, but would only use phonecalls which I don't take or answer or listen to, as a policy, it is designed to protect me legally. Patrick refused to send his communication on the topic in email form because he felt it might put legal liability on

him which may result in justice for me, so he refused, nothing was done about the service cutoff, either by Patrick or ODSP Park which is part of the same organization (defacto on the board it is, they maintain separation on paper so that the denial of basic food, housing, etc, leading to thousands of deaths cannot be directly blamed on CAMH legally. Legally they are separate. In reality, they are one unit.)

My pregnant wife was brutally abused by this system of financial and other abuses directed at both me and her. This directly caused the end of my marriage. As a result of the mental breakdown this financial abuse caused, my wife tried to break open a door with a wooden plank, i was insanely stupid and called the police for help, hoping they would warn her, instead they taught her a lesson she would never forget.

My pregnant wife was put in prison for several days, a gag order issued and continued for 9 months through a prosecution i was begging them to drop charges on, on day 1, they ignored my tears and screams, put my wife in prison with dangerous criminals and gagged her, destroyed the marriage. The inciting incident, the fight, was a mental break down directly based on the financial abuse described here. I have never met my son, he is 5, i likely will never meet him, this resulted in 4 near lethal suicide attempts, several of them extremely bloody. CAMH/ODSP abused my pregnant wife.

Patrick Newland made comments mocking the loneliness his system imposed with poverty and the destruction of my marriage, due to CAMH policies on finances and reporting, He knew all that when he made this comment in an answering machine message "Well Brendan, looks like you're not picking up." It was a poorly disguised double entendre designed to mock the loneliness his system created, which is enough to make a man die, and I almost killed myself over that. He was pointing out that no woman will ever go near me because of CAMH. He was harassing me on a sexual basis, using the relationship he destroyed, my lost son, and the financial ruin imposed by design by DOUG FORD and the CAMH system of cruel and inhuman degrading treatment and punishment. The comment is obviously about pointing out I have no woman, and never will again. Because of him. Because of his system.

Yes, in many ways. My requests are never taken seriously. Like my request for medicine delivery. I had to beg them for three months, just for basic medicine delivery to my home when i'm working. ultimately it required an HRT0 suit (2026-67449-I) & the boss getting fired, before they finally started outright rejecting Martin Rotenberg's orders to deny me this service on the basis of my craziness & record of offenses. (sorry for the odd nature of the record of offenses pleading, technically it is nothing, no record of offenses, of any kind, i have had zero encounters with the justice system, merely a civil suit for attempted murder, & a career criminal's laundry list of crimes listed as mental health incidents & committals. Total Removal from the justice system is a standard TPS protocol, my record of offenses is very long & varied, although on

paper it is nothing, in reality, some of those offenses have likely got me labeled as a "dangerous person" who needs an extra set of eyes on me.)

the system makes romantic relationships permanently impossible due to financial abuse, imprisonment, the infliction of torture leading to trauma and behavioral problems, the systems of CAMH/ODSP [Working in Conjunction as One Unit] attack and viciously chase away romantic partners and relationships by financially abusing and humiliating both the victim and their partner, the abuse is a non-trivial imposition, subtracting the partner's income from their husband, in order to induce hatred of the husband by the wife, the financial abuse of both the wife and husband continues until the breakdown of the marriage soon after it begins. The CAMH/ODSP victim then loses their wife. She leaves and she is with someone else. The victim then kills themselves, or in my case attempted to three or four times, by slashing open the arteries on my hand, or cutting my arm open with a serrated knife, I also attempted to jump off a bridge near my old home (SOLD BECAUSE OF YOU) near Dundas West, down the road.

As they target their victims for mistreatment on a racial and gender basis, Black women are rarely involved, Black Men are a rarity, White women are common, but not too many, White Men are the targeted group the system has singled out as the worst case most abused party, most often selected for mistreatment, abuse, torture, mandated suicide, starvation, mandated loneliness, mandated homelessness, exclusion from the justice system, the destruction of their families, their deaths occurring in full view of their families as they are unable to stop it, watching in distress as their beloved ones die of suicide due to mistreatment they cannot save them from no matter what they try, there is no escape, and a laundry list of other grievous tortures.

Should she have stayed my baby son would have seen his father tortured horribly, continually, endlessly for years, for his whole life growing up. I cannot speak to her anymore, but that is what happened. My belief is that she likely decided, the horror movie CAMH has turned my life into, is rated AO due to the amount blood and other such horrors, that it is not appropriate for a young boy to see such

horrific atrocities and humiliations piled upon his father, and ultimately it was better that he never meet me, than see what CAMH does.

I insist even to this day the lions share of blame for that falls on others, as if i had not prevented the scheduled 12 more days of total starvation, i would have passed out and died along in my condo, dreaming of my wife & dog

The cases will then proceed to a merit's hearing, which should technically be even easier than the Summary Hearing, as my evidence is voluminous and definitive proof of my claims, if considered, of course. The third, ODSP Parkdale, is a Form 1, past confirmation, awaiting an answer on service, which should go through without issue. The Amazon case was withdrawn as I did not understand what i was doing yet. The case: 2026-67449-I was also withdrawn against Shoppers Drug Mart, as CAMH was (i thought falsely) a respondent, and therefore served no real purpose, additionally i did not wish to bring trouble on the Staff there, who have been friendly to me. Ultimately the boss of the store was fired and replaced.

LUCIFERIANISM

Explain why you believe you were discriminated against because of your creed.

Dr Martin Rotenberg of CAMH College and Spadina threatened for several years that future HRTO applications would result in extrajudicial punitive imprisonment in a CAMH Prison Complex, Which has occurred more times than i can count. I would estimate 15 - 20 (744 Hour - 1 Month Imprisonments, under a FORM 1 (purportedly medical in nature)) over the course of my life. The Equivalent of Serious hard time in prison, as if I had committed a murder or serious grievous bodily harm, a significant amount of my life has been spent, wasted, being tortured with humiliating abuse in these monstrous prisons. When The Soundcloud case started, Martin created a dispute out of thin air, purportedly to deny me a charter right (a service, the right to decide my treatment in accord with the law) To suppress this, he starved me of medication, calling around to THE BRIDGING CLINIC and my preferred Walk In Clinic, instructing them both to deny service. Both obeyed. The Soundcloud case was a creed case [and AI demonetization], Martin had also expressed "concern" [a threat of imprisonment in their system of lingo] Over the issue of my use of religious imagery in my songs and on my website. He took particular "concern" [a threat] with

the use of the name JESUS CHRIST in book publishing, which I had adopted previously for religious reasons, in the AMAZON CASES, particularly the SECOND AMAZON CASE [November 2025] Martin stated rather bluntly that this may result in imprisonment in a stone cell.

He often asked me if i was publishing books as Jesus Christ (which i stopped after the Amazon case took away my book publishing platforms, Barnes and Noble was a party to the same case, and also blocked me, giving me no platform to publish books, I had to abandon writing for a time, and gave up writing books entirely, until just recently when IngramSpark agreed to work with me, but as they are not a storefront but a distributor, the blanket ban on my books [there are over 50] remains in effect, and i am forced to seek alternative means to get my writing seen by someone. [like self publishing through IngramSpark and other forums like this.]) Martin continually telegraphed threats of imprisonment should i ever file another HRTO SUIT, or use the religious name JESUS CHRIST in publishing.

He threatened imprisonment may soon follow should either case prove true. When Soundcloud finally emerged,

He starved me of medication 1 day after application was filed with EFILE, likely in order to create a situation where i would be perceived as insane and lacking credibility. It is true i need my medication,

But when I am medicated I am not just ok,
I am an extraordinarily intelligent and articulate

legal mind, an artist of note with 2.25 million views on Soundcloud, making beautiful AI music which will live forever, a skilled computer programmer, AI designer and web designer (these would all be classified as grandiose delusions, and therefore increase the likelihood of a humiliating stay in a CAMH Prison complex, my a non-trivial margin, though not necessarily actionable on it's own, on a balance of factors (most of them protected code grounds) they can contribute to a longer stay in the CAMH Prison system, or more likely to trigger an incarceration order. They increase the odds of being ordered into a CAMH prison, much like additional included do in the justice system we do not have access to) [there is a one tiered justice system with CAMH victims entirely outside of it. There is no exception to this, we are removed from the justice system, and work on this system instead.] All this primarily is based on our "protected" characteristic of "mental illness", a soft term i hate, I would prefer the term crazy. [If possible i request people use this term as CAMH language disturbs me] There are an assortment of other factors, but it is ultimately the case that this is based on my craziness. Though I'm not particularly impaired, if medicated i live a mostly normal life, and even thrive and excel. I have asked in my filings that CAMH be abolished, When that happens, pharmacies can dispense the medication instead. [the edifice of Prison Complexes, and brutal mistreatment resulting in thousands of deaths every year, is not needed, and realistically prosecution should follow. As they have created a system reminiscent of the worst regimes in human history. Which also couched their abusive mistreatment in the language of "compassion" and "concern"]

I am crazy [schizoaffective disorder manic type - a clinical term with 11 syllables, describing me like a science experiment or a pfizer medication name - I prefer crazy, it is simple and direct, one syllable, it was the term that was used for us before they started calling us "mentally ill" which i am not, back when we were treated better, then came the term "mentally ill" and all the abuses that followed.]

Explain why you believe you were discriminated against because of your disability or perceived disability. *

Everything described in this entire document (covering maybe 10% of the abuses I'd like to address) has been because I am crazy. (a protected characteristic) It justifies arbitrary and unfair imprisonment for years gouged out of my lifetime. It creates an entirely separate and parallel justice system, which, in order to prevent us from "hurting ourselves" in court, by saying and doing stupid things presumably, the right to hearing, a trial, criminal justice, filing a report with the hate crimes unit, reporting a series of spitting assaults based on my protected characteristic of crazy, the right to face your accuser in court, the right not to be arbitrarily detained and jailed without a lawyer, a courtroom, evidence, a trial, a hearing, a verdict, a decision, appeals. The entire justice system is denied to us (as we'd only hurt ourselves with it anyway), rather when we are assaulted, if we report the assault or press the issue, the police will offer hot meals and homeless shelters to people living comfortably at home, they will declare us "in distress" by default, just for calling, and instead of facilitating criminal charges against the who assaulted us, we are subject to immediate imprisonment without trial in a CAMH Prison complex, for a term of 1 month or longer (The Form 1 is a lie, there are no 72 hour holds, they file additional forms immediately to keep you for a month, or longer, or for life, or cut out pieces of your brain[in certain circumstances]) This is the result of liberal leftist policies, designed to "keep mentally ill people out of the justice system" or "avoid armed officers being sent to their door" Armed officers are sent to their door, and they are then imprisoned without trial, with no appeals, no evidence, no lawyers, no justice system of any kind. As it is seen as..... they claim, damaging to us..... The alternative they provide is no justice system at all. A system of Prison Complexes and Research Facilities entirely replacing the justice system and locking us out permanently. Accusations against people who assault and victimize us, are thrown out, as the ravings of a crazy man [SEE: mentally ill] and the perpetrators of violence against us are allowed to go free, without so much as an investigation or a POLICE REPORT FILED, 2026-67461-I.

This was apparently the result of an altercation, where Toronto Police shot to death a crazy man who

was waving a knife around, this was seen as a tragedy, and to overcome it, we were stripped of all rights under the justice system on the basis of our code protected grounds. We can no longer face our accuser in court, their story is taken by default as true and we are taken away. We can no longer file charges against people who assault us, instead we are jailed for being "in distress"

even when perfectly calm and trying to file a police report.

A month in a stone cell follows, surrounded by dangerous criminals and weird dingbats and bullies, who torment the victim for a term of 744 hours on average, A FORM 1 HOLD FOR OBSERVATION, a humiliating form of torture.

If the Toronto Police cannot prevent themselves from shooting crazy people, without simultaneously then going on to reduce them to chattel with no rights under the justice system, we need a new police force, they are not functional, they've lost their minds. It is total

So he has condemned them to death by the thousands.

Anyone who received those tax cuts is spending blood money.

Most of the city voted for it, most of the city bears extreme prejudice and hatred against crazy people, generally they are happy when we die,

They have no compassion of any kind whatsoever.

It is beyond the scope of HRTO to even begin to address, but what little can be done here, I think should.
